

**RELEASE AND WAIVER OF LIABILITY  
AND ASSUMPTION OF RISK AGREEMENT  
August 2018 - August 2019 Minor member**

FOR GOOD AND VALUABLE CONSIDERATION, including permission to participate in **High School Rodeo activities including Mechanical Bull Riding, and Live Rough Stock**, and related activities, per Jefferson County Fairgrounds. This includes myself, my successor, heirs, assigns, executors, and administrators;

1. Agree, that prior to participating, I will inspect the facilities, equipment and areas to be used, and, if I believe any of them are unsafe, I will immediately advise the person supervising the event, activity, facility, or areas;

2. Acknowledge that I fully understand that participation may involve risk of serious injury or death, including economic loss which may result not only from my own actions, actions of my child, inaction's, or negligence, but also from the actions, inaction's or negligence of others, the condition of the facilities, equipment or areas where the event or activity is being conducted, the rules of play, or this type of event or activity.

also referred to as "child", including medical or hospital bills, permanent or partial disability, death, and damage to my property, caused by or arising from participation in this event or activity;

Covenant not to sue or present any claim for personal injury, property damage, or wrongful death against Jeffco Juniors Rodeo Team / **Jeffco High School Rodeo Team (the "TEAM")**, as **Permittee/Sponsor, their instructors, board members, agents or volunteers, OR JEFFERSON COUNTY OR THE JEFFERSON COUNTY FAIRGROUNDS (the "COUNTY")**, their officials, board members, agents or employees, attributable to **child's** participation in the event or activity;

Release, waive, discharge and relinquish the "TEAM", **Permittee/Sponsor, their instructors, board members, agents or volunteers, AND THE COUNTY**, its officials, board members, employees and agents from any liability, loss, damage, claim, demand or cause of action against them arising from or attributable to the "child"'s participation in the event or activity, whether same shall arise by their negligence or otherwise;

6. Agree that photographs, pictures, slides, movies, or videos may be taken in connection with participation in this event or activity without compensation from the "TEAM", **Permittee/Sponsor, their instructors, board members, agents or volunteers, OR THE COUNTY**, and consent to the use of these photographs, pictures, slides, movies or videos for any legal purpose;
